



## METALLA DECLARES MONTHLY DIVIDEND

Vancouver, British Columbia: **Metalla Royalty & Streaming Ltd.** (“Metalla” or the “Company”) (TSXV: MTA) (OTCQX: MTAFF) (FRANKFURT: X9CP) is pleased to announce that its board of directors has approved and declared a monthly cash dividend payment of CAD \$0.0015 per share for February, March, April, and May 2019 on its common shares (subject to any applicable tax withholding obligations).

The table below sets out the monthly record and payment dates for shareholders of record. The Company plans to expand its dividend throughout the year targeting a payout ratio up to 50% of its operating cash flow after taxes and general and administrative expenses. The dividend should provide shareholders with a link to gold and silver prices through the performance of the Company’s royalties and streams.
